We dedicate ourselves to the memory of Florence Terry Griswold, whose faith and confidence in the cooperation of all peoples of the Western Hemisphere made possible in the founding of the first Pan American Round Table in San Antonio, Texas, in 1916, and whose inspiration is our guide today and through the years ahead.

## **OBJECT**

The object of the Pan American round Tables shall be “to provide mutual knowledge, understanding and friendship among the women of the Western Hemisphere.”

To foster all movements leading to a higher civilization, especially those affecting the women and children of these countries.

The Pan American Round Table is not an institution nor a system, but a movement prompted by a series of factors; geographical continuity, similarity of institutions, love of democratic principles and community of internal aspirations and trends.

It is non-political, non-sectarian and non-federated, and is designed to interpret itself in acts tending to draw more closely the social and cultural bonds of the Americas.

The whole purpose of the Pan American Round Table is to acquaint the members with the language, geography, history, literature, arts, culture and customs of the republics of the Western Hemisphere; for through knowledge, understanding is gained, and understanding leads to friendship.

# **PAN AMERICAN ROUND TABLE I OF FORT WORTH CONSTITUTION**

## **ARTICLE I**

### **NAME**

The name of this organization shall be Pan American Round Table I of Fort Worth, Texas.

## **ARTICLE II**

### **OBJECT**

This organization shall be non-political, non-sectarian, non-profit sharing and non-commercial. The object of the organization shall be;

(1) To provide mutual knowledge, understanding and friendship among the women of the Western Hemisphere.

(2) To foster all movements leading to a higher civilization, especially those affecting the women and children of the countries of this hemisphere.

## **ARTICLE III**

### **AFFILIATIONS**

In as much as Pan American Round Table I of Fort Worth is a member of the Alliance of Pan American Round Tables, and also in accordance with Article II of the original constitution of the Pan American Round Tables, it shall:

(1) Take part in only such activities as have a direct bearing upon the stated object of this above named Round Table.

Affiliate with organizations of Pan American Round Tables—State, National, or International – provided local autonomy is maintained.

## **ARTICLE IV**

### **Membership**

Section 1. All women who are in sympathy with the object of this organization, who are willing to cooperate in its works and to conduct themselves with decorum, may be eligible for membership.

Section 2. Membership in the Pan American Round Table shall be by invitation. Completed membership forms of person recommended for membership shall be submitted to the Chairman of the Membership Committee. These forms shall bear the signature of the sponsor and two (2) co-sponsors. The applicant must be known by all signers and must have attended at least one meeting of the Table.

Section 3. The names of proposed members, after majority approval of the Membership Committee and Executive Board, shall be accepted for membership. Notification shall be made verbally by the Director with a letter to follow by the Corresponding Secretary.

### **Section 4. DUES**

The annual dues are payable April 15<sup>th</sup> and are delinquent June 1<sup>st</sup>.

(a) Dues for all members except Honorary and Special are fifty (\$50.00) per year.

(b) Dues for new members joining after December 1<sup>st</sup> shall be twenty five dollars (\$25.00).

(c) Allocation of dues: **State:** \$6.00 per member; **Florence T. Griswold Scholarship Fund:** \$2.00 per member; **Alliance:** \$15.00 per Table; **Alliance Travel Fund:** \$3.00 per member or not less than \$22.00.

Monies shall be sent to the State and Alliance Treasurer, designating the amounts for State dues, FTG Scholarship Fund and to the Alliance Treasurer for dues and Travel Fund.

Section 5. Membership may be active, sustaining, honorary, or special.

- a) Active members: shall not exceed one hundred (100). They shall participate on committees, programs and projects of the Table. They shall have all rights and privileges of the Round Table. Any member wishing to resign or be placed on sustaining must notify the Recording Secretary or Director.
- b) Sustaining members: Active members may, for personal reasons, ask to be placed on the sustaining list. Active members notify the Recording Secretary if they wish to be placed on the sustaining list. Sustaining members may participate in Table activities, but without the privilege of serving as officers or on standing committees. They have the privilege of voting, however.
- c) Honorary members: The title of honorary membership may be conferred upon a man or woman for distinguished service, and upon consuls, and their spouses during their residence in the locality. Honorary members are exempt from dues but shall be responsible for their own luncheon fees. They may participate in the edification and social activities of the Table, but may not vote.



d) Special members: Special membership is granted at the discretion of the Executive Board to PART I members who are ill or infirm and unable to attend regular meetings but would still like to affiliate with the membership. Special members are not required to pay dues and do not have voting privileges.

Section 6. Any member who has resigned in good standing may request reinstatement of membership, such request being made in writing to the Membership Committee and approved by the Executive Board.

Special consideration shall be given to transfer members from other Tables. They shall be invited to become active members upon approval of the Executive Board and the Membership Committee.

Section 7. Any member, who at the discretion of the Executive Board no longer qualifies as a member of this Pan American Round Table may be dropped from membership by a two-thirds (2/3) vote of the Executive Board. The member so dropped shall be notified by letter by the Corresponding Secretary under the direction of Table Director.

## **ARTICLE V**

### **Officers**

Section 1. The officers of Pan American Round Table I of Fort Worth shall be Director, Associate Director, Recording Secretary, Corresponding Secretary, Treasurer, two Custodians, Historian, Parliamentarian, Member-At-Large and Immediate Past Director. These officers shall constitute the Executive Board.

Section 2. All Officers shall be elected for a period of one (1) year. Officers may be re-elected to a second consecutive term not to exceed two years.

Section 3. The Board of Directors shall consist of the Executive Board and the Chairmen of the Standing Committees.

## **ARTICLE VI**

### **Standing Committees**

The Standing Committees shall be: Archives and Library, Budget and Finance, Coordinating and Costume, Friendship, House Social and Decorating, Language, Membership, Projects-Scholarship, Publicity and Photography, Telephone and Reservation, and Yearbook.

## **ARTICLE VII**

### **Meetings**

The club year of the Table shall be June 1 through May 31. Regular meetings shall be held once a month from September through May on a day designated by the Executive Board, usually the Second Wednesday or Second Saturday. The hour and place shall be determined by the Program Chairman and the Executive Board. The May meeting will be reserved for new officer installation.

## **ARTICLE VIII**

### **Amendments**

This Constitution may be amended at any regular meeting by a two-thirds (2/3) vote of the active members provided the notice of the amendment has been given at a previous regular meeting or in writing to the membership.

### **QUORUM**

One-third (1/3) of the active membership shall constitute a quorum for a business meeting.

# **BY LAWS**

## **ARTICLE I**

### Executive Board

Section 1. The elected officers and one active member to be known as the Member-At-Large, together with the Immediate Past Director, shall constitute the Executive Board. It shall be called by the Director or Acting Director in the interim of regular meetings. It shall have the authority to transact all business of the Table and also any new business whose urgency does not permit its postponement until the next regular meeting. Six shall constitute a quorum.

Section 2. In the event that the Immediate Past Director should become an inactive and/or sustaining member, for any reason, the preceding Past Director shall become a member of the Executive Board in lieu of the Immediate Past Director.

## **ARTICLE II**

### Officers

Section 1. Director: The Director shall preside at all meetings; appoint all standing and special committees (ad hoc committees) except the Nominating Committee and the Auditing Committee, and be ex-officio member of all committees except Nominating and Auditing. She, or her appointee shall represent the Table on all occasions.

Section 2. Associate Director: In case of absence or disability, the Associate Director shall perform the Director's duties. She shall accept an assignment by the Director that is for the extension of this Table. In the Event of resignation or death of the Director, the Associate

Director will assume her duties and title. The Associate Director shall be in charge of Programs.

Section 3. Recording Secretary: The Recording Secretary shall keep a record of all meetings and a complete roll of all members. This roll shall consist of the name and address of each member, her classification of membership, and the date of her admission into the organization.

Section 4. Corresponding Secretary: The Corresponding Secretary shall conduct and have charge of all correspondence, including cards to ill or bereaved members. She shall notify new members of their election and dues payable. If a candidate fails to be elected for membership, the Corresponding Secretary shall notify the member proposing her. She shall preserve all papers and letters of importance pertaining to the affairs of Pan American Round Table I of Fort Worth.

Section 5. Treasurer: The Treasurer shall have in her charge all funds belonging to the organization and shall pay out all budgeted items and all other bills only upon the authority of the Executive Board. She shall keep a correct account in detail of all monies received and expended and shall render an account in writing each month, and at the end of the year, to be filed with the Recording Secretary on or before June 30 and given to the Auditing Committee within 10 days following.

Section 6. Custodian: The Custodian shall have in her charge all properties belonging to this Round Table and shall be responsible for their preservation. She shall not make loans of any properties without

consulting the Director and Associate Director, who shall share in the responsibility of their return.

Section 7. Historian: The Historian shall keep a record of all major activities and shall keep in organized form yearbooks, programs, newspaper clippings, photographs and other significant information pertaining to the history of Pan American Round Table I of Fort Worth.

Section 8. Parliamentarian: The parliamentarian shall see that business procedure of the Round Table is conducted according to the Constitution, the By Laws and Robert's Rules of Order, Newly Revised.

## **ARTICLE III**

### **Duties of Members**

Section 1. Each active member shall serve on a standing committee and on a program of the country she represents. She shall collect news articles on the country she represents and read them to the membership at roll call.

Section 2. Each member shall be responsible for her luncheon charge unless she has notified the Reservation Committee 48 hours preceding the luncheon or program that she or her guest will be unable to attend. Any members failing to cancel a reservation for herself or her guest will be responsible for the luncheon charge which shall be paid to the Treasurer.

## **ARTICLE IV**

### Nomination and Election of Officers

Section 1. Officers of this Round Table shall be elected in this manner:

A Nominating Committee of three shall be elected at the January meeting. The Chairman shall be the first person of the three named. At the February meeting the Nominating Committee shall present the slate of officers to be voted upon at the March meeting. Additional nominations may be made from the floor provided the nominees' consent has been obtained. The Member-At-Large shall be elected at the March meeting. If there is more than one nominee for an office, voting for that office shall be by secret ballot.

Section 2. Officers elected in March shall be duly installed in May and shall enter upon their duties June 1.

## **ARTICLE V**

### Duties of Standing Committees

Standing Committees shall be composed of not less than three members, and not more than five, with the exception of the Auditing and Finance, which shall have only three, and the House Social & Decorating, Program, and Telephone and Reservation Committees which may have as many members as needed to carry on their work efficiently.

Section 1. The Auditing Committee shall be elected by the Executive Board in March. It shall consist of the Treasurer and two active members.

Section 2. The Archives and Library Committee shall have as its specific duty to coordinate the State Project, which is to encourage the exchange of books, magazines, pictures, and programs. They shall have charge of the Archives of Pan American Round Table I, which are located at the Fort Worth Public Library. This committee shall serve as a gathering agency for material of historical value including Table yearbooks to be sent to the Archives of the State and Alliance, at the University of Texas at Austin. These items are to be sent to the Historian and Interchange Library Chairman of each organization.

Section 3. The Budget and Finance Committee shall consist of three members, one of whom shall be the Treasurer. The Committee shall outline the financial policy of the Table and shall prepare a budget which shall be reported at the September meeting. All expenditures shall be considered by the Budget and Finance Committee and approved by the Executive Board before any action may be taken by the Table.

Section 4. The Coordinating and Costume Committee shall have as its specific duty the coordinating of community interests and those of Pan American Round Table I of Fort Worth. One of its duties shall be the planning of a city-wide observance of Pan American Week in April in conjunction with the House Social and Decorating Committee. The Coordinating and Costume Committee shall encourage members to acquire costumes of the Americas, especially of the country each is



studying, shall pass on the authenticity of such costumes and shall have style shows of the costumes at appropriate times.

Section 5. The Friendship Committee shall work with the Corresponding Secretary to contact Table members who have not been regular in attendance and to contact ill or bereaved members on behalf of the Table.

Section 6. The House Social and Decorating Committee shall be responsible for all social affairs and entertainment. It shall represent the membership when the Round Table is asked to assist in the reception and entertainment of outstanding persons from other countries of the Western Hemisphere. Members of the Committee shall have charge of decorations for the tables at the Christmas party, the Pan American festivities on Pan American Day in April and shall serve as hostesses at those meetings.

Sections 7. The Language Committee shall try to provide Spanish classes and meeting places for teachers for such classes.

Section 8. The Membership Committee shall keep vacancies filled and shall handle all recommendations for membership as per the Constitution, Article IV.

Section 9. The Program Committee shall be responsible for obtaining a meeting place before the first meeting of the year, and for the programs and menus for the luncheon meetings. The chairman of the Program Committee shall provide the Yearbook Committee a list of the programs for the year to be published in the yearbook.

Section 10. The Project-Scholarship Committee shall recommend to the Executive Board the project to be sponsored by the Table and it shall be voted on at a regular business meeting. Each recommendation must be carried by a two-thirds (2/3) majority of the Executive Board.

The permanent project of this Table shall be educational. All unallocated monies in the Service Fund shall comprise the Educational Fund, which shall finance the project. The purpose of the Educational Fund shall be to assist worthy persons who are attending a college or university in Fort Worth or the surrounding region and who have attained a junior or senior classification. The young person so assisted and the amount of money to be endowed shall be determined yearly by the Executive Board of the Table with approval by the membership.

Section 11. The Publicity and Photography Committee shall be responsible for announcements and photographs in the daily papers of meetings and other activities of the Round Table. The Committee shall be charged with taking photographs at meetings and special Pan American events, giving same to the Historian for the Press Book. This Committee shall also be responsible for publishing and mailing the Table Panamericard consisting of information concerning the monthly program, any messages from the Director, and news items of interest.

Section 12. The Telephone and Reservation Committee shall have as its duties the following:

- (a) To take reservations and cancellations for luncheons and other functions where reservations are required.
- (b) To collect luncheon fees at each meeting.

(c) To inform members regarding matters not publicized through regular channels.

Section 13. The Yearbook Committee shall be responsible for preparing the yearbook for the ensuing year, which shall contain a list of members in good standing, the programs for the year, the names of the current officers and standing committees, country representatives, the Constitution and By Laws and all Standing Rules.

Section 14. Other committees may be appointed from time to time by the Director (ad hoc committees) for the advancement of the Round Table.

## **ARTICLE VI**

### **STANDING RULES**

1. Each member may invite as many guests as she wishes, at her own expense.
2. Chairman of the Day and her Committee are responsible for a speaker or other programs to represent their country and for sending an acknowledgement to said speaker, and for providing decorations. A member of the Committee should give the Invocation.
3. State Convention: Pan American Round Table I of Fort Worth shall be responsible for two (2) delegates, who have one vote each to the State Convention. The Director and Associate Director shall be designated as delegates if they will attend. The

two alternates shall be elected from the membership. The Table shall pay \$100.00 towards the convention registration fee for the Director.

4. Alliance Convention: Pan American Round Table I of Fort Worth shall be responsible for one (1) voting delegate and two (2) alternates to the Alliance Convention. The Director shall be the designated delegate and the Associate Director her alternate. If either, or both, are unable to attend, the delegate and alternates shall be elected from the membership. The Table shall pay \$100.00 towards the convention registration fee for one (1) voting delegate to the Alliance Convention.
5. The fiscal year for the Table shall be June 1 to May 31.
6. All checks issued by the Table, which have not been cashed in the fiscal year in which they are issued, will become void. Funds may be issued at the discretion of the Executive Board.

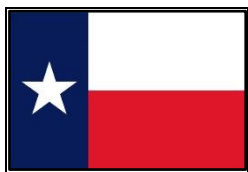
