to epidemiological problems. Her main objective is to do research and to work with health decision makers in her country so as to find solutions for the many social and health-related problems that exist in Colombia.

Miss Gonzalez has attended the Mathematical and Theoretical Biology Institute at Cornell and has worked in the Universidad Autonoma de Occidente. She desires to return to her country to share her knowledge by teaching and by doing research in Mathematical Biology. **FTG Scholarship II**, in the amount of \$2,000 was awarded to <u>Sulamita Mora</u>, whose family is from Michoacan, Mexico. She is a Masters student of Clinical Social Work at the University of Texas in Austin.

Her passion for learning led her to the field of Social Work as her career and to be an advocate for human rights issues, such as human trafficking, immigration, domestic violence, etc. Her goal is to counsel families in Central and South America.

As her final field placement, Sulamita has been accepted to "Nuestros Ahijados" in Antigua, Guatemala, an organization that offers education, medical services and much more to the people of the San Felipe Slums. Her duration of 4 months in Antigua will enable her to be more confident as a professional and to improve her research skills.
